Drinks and beverage

Menus and drink packages are specified in the Wedding packages sent along with this contract. Different option can be offered and dishes can be replaced, if there is any additional cost it will be communicated accordingly. Only food and beverage supplied by Minthis Club House Ltd will be consumed and accepted.

A late bar charge of 500, 00 Euro per hour (Five Hundred) - per hour will be applied if clients will not leave the venue by 1 am. We will accept guest maximum until 3 am and all drinks will be charged upon consumption along with venue late bar charge.

Entertainment

All the entrainment must be discussed with management and approved by Minthis Club House Ltd. We reserve the right to close the bar and terminate or reduce sound level of the music should the situation demand it.

Attendees

The quotes in the packages are based on a minimum guarantee of « 40 ATTENDEES for the club house - 100 for the green lawn and 180 for the tent».

The final number of attendees is required in writing 72 hours prior to the event; the couple will be financially obligated to the minimum guarantee or the list given 72 hours prior, whichever is greater. Should confirmed numbers deviate from the minimum guarantee the Minthis Club House LTD reserves the right to amend the space booked and rates offered. If the number of guests increases the couple will be charged as per the actual head count on the day of the event.

For the Club House we can accept a smaller number of guest with a minimum spending of 5.000,00 (Five thousand) Euro.

Set Up & Equipment/ Property damages

The Organizer (name of the couple) is responsible for any damage to the property, fittings, furnishings, fire equipment, safety equipment, walls, floors, elevator, toilets, carpets etc. Any damages caused by your organization or /and your suppliers will be charged to your final bill. The management will assist in every possible way with the storage of the equipment and decoration but we will NOT accept any liability for any loss or damage. We advise the organizer or the client to issue a proper insurance. We are not responsible for any personal belonging and /or personal property left in Minthis Club House Ltd, wardrobe and in any other area of our property. We do not accept any liability for any damages caused to attendee's cars/van or motorcycle.

Marquise and tent

Our marquise can be ordered and placed only through Minthis Club House Ltd.

Prices are indicated in our packages. No external supplier (direct or indirect) can set up the marquise.

A non-refundable deposit of 5.000,00 (five thousand) Euro is requested to confirm and block the marquise.

Once the amount is received we consider this service confirmed.

Cancellation Policy

Minthis Club House Ltd reserves the right to cancel the event and refund deposit in the following cases:

- In circumstances when a booking is made through a false third party different from the one indicated or under false pretenses.
- The booking might prejudice the reputation of the resort
- Guests attending the event might behave in any way considered to be detrimental, offensive or contrary to normal expected standard of behavior.

Any falsification will render the contract null and void

Any cancellation from the client's/ agent's side has to be communicated in -writing_ and is subject to the loss of the deposit. Furthermore, the following shall apply:

- A 10% on the total amount of the provisional budget and on the numbers originally booked will be charged if the cancellation comes between 24 to 10 weeks before the event
- A 30% on the total amount of the provisional budget and on the numbers originally booked will be charged if the cancellation comes between 9 to 5 weeks before the event
- A 50% on the total amount of the provisional budget and on the numbers originally booked will be charged if the cancellation comes between 4 to 2 weeks before the event
- 100% on the total amount of the provisional budget and on the numbers originally booked will be charged if the cancellation comes 14 working days before the event

Decoration

Any decoration should be discussed and approved by management. Decorations must respect the standard and style of the resort. In all areas of our resort, monastery, cocktail area, open spaces, club house and in every single space of our property, confetti and any plastic decorations that can pollute and disfigure the resort are NOT allowed. The only confetti allowed are petals of real roses and NOT of plastic and/or grains of rice (only and exclusively in the area of the monastery). For any fireworks the management is happy to indicate one of our trusted suppliers who can provide this service respecting our standards.

-Guarantee and payment

Upon securing the wedding date, the client agrees to all included terms and conditions.

After the deposit of 1.000,00 Euro an additional 50% of the total amount is required 5 weeks before the date of the wedding once the provisional budget is sent. The total settlement will be made during the final meeting not later than 2 days before the event. Any extra amount during the event will be settled before leaving the venue.

Requirements to ensure the wedding / event is confirmed

In order to ensure your wedding/event at Minthis Club House Ltd the present contract should be signed below and initials should be placed on every single page and return to the management.

Minthis Club House Ltd will give a **5 working** days period from signing of the contract for the following requirements to be received:

1. The non refundable deposit as stated above.
2. Identification with names/address /nationality of the couple/clients.
3. This contract signed with company stamp.

Minthis Club House Ltd has the full authority to release any space if the above is not received on time.

Please be advised that once this agreement is signed, the same is considered as part of a contract and subject to local laws.
